You agree that no prior-notification will be provided unless the date or amount changes, in which case you will receive notice from us at least 10 days prior to the payment being collected.

In the case of an ACH Transaction being rejected for Non Sufficient Funds (NSF) I understand that **RED RIVER UNITED** may at its discretion attempt to process the charge again within 30 days, and agree to an additional **\$7.50** charge for each attempt returned NSF which will be initiated as a separate transaction from the authorized recurring payment. I acknowledge that the origination of ACH transactions to my account must comply with the provisions of U.S. law. I certify that I am an authorized user of this credit card/bank account and will not dispute these scheduled transactions with my bank or credit card company; so long as the transactions correspond to the terms indicated in this authorization form.
